



## PET (Dog or Cat) Registration Form

EXCEPT DURING EVENTS, THE PARK ALLOWS PET OWNERS TO BRING CATS AND DOGS (ONLY) INTO THE SPIRIT OF THE SUWANNEE MUSIC PARK ®. HOWEVER, THE PARK MANAGEMENT RETAINS THE SOLE DISCRETION TO DECIDE WHETHER OR NOT TO ALLOW PETS. IF YOU WISH TO BRING YOUR PET INTO THE PARK, THEN YOU MUST COMPLETE THIS FORM. SUWANNEE COUNTY CODE SECTION 14-33 REQUIRES EACH DOG OR CAT TO WEAR AN IDENTIFICATION TAG WITH THE OWNER'S NAME, ADDRESS AND PHONE NUMBER; AND TO WEAR A TAG SHOWING AN ACTIVE ANTI-RABIES VACCINATION. IF YOU DO NOT MEET THESE REQUIREMENTS FOR EACH PET, THEN DO NOT BRING THE ANIMAL TO THE PARK. IN ADDITION, YOU MUST SIGN THIS FORM ACKNOWLEDGING THAT YOU AGREE TO ABIDE BY THE PARK'S TERMS AND CONDITIONS. DURING SPECIAL EVENTS, PETS (DOGS AND CATS ONLY) MAY BE ALLOWED IN PORTIONS OF THE CAMPGROUND, BUT NEVER IN ANY MUSIC VENUE, THE MUSIC HALL, THE COUNTRY STORE OR THE SOS CAFÉ. A LEGITIMATE SERVICE DOG, UNDER THE AMERICAN'S WITH DISABILITIES ACT DEFINITION IS NOT A "PET." NOTE, ANYONE WHO MISREPRESENTS HERSELF OR HIMSELF AS USING A SERVICE ANIMAL COMMITS A CRIME AND IS SUBJECT TO ARREST, FINES AND PRISON UNDER SECTION 413.08(9), FLORIDA STATUTES.

## Pet Owner Agreement:

As a condition for bringing your pet into the Park, you must carefully read, and agree to the following terms:

- I AGREE that I am liable for any problems, damage, or injury that my pet is involved in, with fault or blame not a consideration for my liability.  Yes, I Agree  Initial
- I AGREE that I am aware that in the event my animal is lost, injured or killed, Cornett's Spirit of the Suwannee, Inc., James C. Cornett, and/or Park Staff are not liable. I am bringing my pet at my own risk and I will keep my animal on a leash (leash not more than 6 feet long) and I will not leave my animal unattended at any time.  Yes, I Agree  Initial
- I AGREE THAT I AM NOT ALLOWED TO TAKE MY PET INTO THE MUSIC HALL, COUNTRY STORE, SPIRIT CAFÉ, MUSIC VENUES OR FOOD VENDING AREA.  Yes, I agree.  Initial.
- I AGREE THAT I MUST PICK UP MY PET'S DROPPINGS AND PLACE IN THE TRASH.  Yes, I agree.  Initial.
- I understand that I am not allowed to bring my pet to any music festival at the Spirit of the Suwannee Music Park.  Yes, I understand.  Initial.
- I understand that if my dog engages in excessive barking, biting, jumping, or otherwise creating a nuisance then I can be required to immediately pack up and leave the premises without any refund.  Yes, I Agree  Initial
- I understand that if I bring any pet into the Park without a registration, or if I misrepresent any information on this registration form that I can be immediately ejected from the premises without a refund, and that I may be permanently banned from the Park.  Yes, I Agree  Initial
- I understand that If I am renting a cabin from the Park, that I am required to inform the front office staff immediately upon check in, so that I can be placed in a pet-friendly cabin. If I bring my pet into any non-pet-friendly cabin then I agree to pay a \$200. Cleaning fee/penalty.  Yes, I Agree  Initial
